*The selected students must apply online in HMS portal (<https://iiesthostel.iiests.ac.in/>), based on which allotments will be given by the Mess Section of the institute. **Once allotted, they must pay the fees. Their arrival and staying in the hostel will not be a factor.***

If not applied online and not paid within scheduled time as per notification, then next candidates from next list will be considered. No appeal will be considered after that.

All selected candidates must collect Hostel Allotment Slip from Mess Section of the Institute after full payment. (In between 11.00 am to 5.00 pm), in working day only. After that they can report to their allotted hostel.

- (1) HMC reserves the right to alter the allotted Hostel, if required, any time. HMC also reserves the right to change Hostel and Mess dues. The candidates will be notified about the change through the website.
- (2) All students are requested to follow the notice released by the Dean of Students/HMC.
