#### OFFICE MEMORANDUM

Sub: Advisory regarding implementation of systemic improvement in the matter of procurement of goods -reg.

The undersigned is directed to say that it has been observed that the institutes/universities coming under the jurisdiction of MHRD usually purchase the equipments before completion of associated civil/electrical works. Subsequently due to non-completion of associated works, the equipments remain unutilized and some time even they become obsolete due to technological changes resulting loss of huge money of the government.

- 2. Considering seriousness of the matter, Central Vigilance Commission has advised CVO, MHRD to implement systemic improvement to avoid procurement of goods without considering allied civil/electrical works.
- 3. In view of the above, it is requested that all the institutions/universities/organizations/ subordinate offices coming under the administrative control of the respective Bureau may be advised for strictly compliance of Commission's advice and ensure that before placing order to buy any equipment, the institution must make sure that it will be immediately put to proper use i.e. the space is ready to install it and required specialized manpower, if any, to run it, is available.
