TECH. SPECIFICATION:

- 1) Triple Seater Bench cum Desk: Suitable for all types of educational institutions. Sturdy and long lasting student desking system. Durable 18 mm Pre laminated Particleboard top, seat & back with rounded edges 2mm PVC edge. Storage option-shelf/hanging clip on both sides. 18 mm Pre laminated Particle Board shelf with 2 mm thick PVC lipping and cladding of 1 mm thick CRCA steel sheet. Frame structure to be made of 25 X 25 X 1.2 mm thick CRCA sq. pipe. 50 micron thick Epoxy powder coated paint finish of desired color.
Triple Seater: Only Desk size: (L) 1500 X (D) 400 X (H) 750 mm. Seat Size: 1500(L) x 300 (D) x 450 (H) make: Godrej/Bombay safe/ Wipro

This may kindly be noted that the rate to be quoted inclusive of carrying cost etc, all taxes to be mentioned separately. Rate should be valid till 31st march 2019. **The vendors must have to submit a Xerox copy of each certificate (ISO 9001 – 2008, ISO**

14001, OHSAS 18001 and BIFMA) of the manufacturer of the furniture with the quotation. Otherwise their quotation will not be considered. The vendor must have PAN Card, GST No., trade licence etc.

- The bidder/manufacturer should have Computerized Numeric Control (CNC) controlled press form brake for sheet metal bending technology for which supporting certificates such as purchase bill/ installation certificates should be provided with the offer, otherwise their offer will not be considered .
- The bidder/manufacturer should have pressing technology (Hot press) to process postlam and post formed profile for furniture panel for which supporting certificates such as purchase bill/installation certificates should be provided with the offer, otherwise their offer will not be considered.
- Bidder shall furnish an undertaking for providing Comprehensive onsite warranty for any manufacturing defect for a period of three (03) years for the furniture from the date of supply/installation on their letter head, failing which, their offer will not be considered.
- Bidder/manufacturer must have manufacturing facility certified by ISO 9001:2008, 14001:2004 & OHSAS 18001:2007.
- Bidder/manufacturer must have BIFMA Membership/registration following the requirements prescribed for comfort, safety, sustainability & durability.
- The manufacturer or bidder should be registered under TRADE MARKS ACT by the Govt. of India. Supporting documents must be enclosed self attested.
