This is for information to all concerned that the Undergraduate (UG) students admitted in the academic session 2019-20 or after are eligible for full/partial tuition fee waiver provided their total family income does not exceed Rs. 5 Lakh in the last Financial Year, i.e. 2021-22. In view of that, applications are invited from the 2nd (currently Second Semester), 3rd, 4th, 5th year (B.Arch) students in the academic session 2022-23. For this purpose, the concerned students must use the link (https://bit.ly/3tYKSle) of the Google Form to fill the requisite information and upload their Family Income Certificate (PDF), issued for the period 1st April 2021 to 31st March, 2022.
