FREQUENTLY ASKED QUESTIONS (FAQ's)

(PG Scholarship)

Q1	What are the documents required to be uploaded by the student?
Ans.	Students are required to upload to following document:
	Scanned PDF copy of the passbook
Q2.	Can the Joint Account with family members be uploaded? (The PDF copy of the same.)
Ans,	No, Joint account is not accepted. Only Basic General Savings account/Normal account should be opened in UCO bank BESU BRANCH. Student should open "NO FRILL ACCOUNT".
Q3.	During the period of the course can a student open a fresh Bank account or change the Branch of Savings Bank account
Ans.	Bank and Branch should not be changed during the period of course preferably for smooth disbursal of PG scholarship.
Q4.	Whether students are entitled for grant of any kind of medical leave, leave taken in emergent cases during the total duration of 24 months of the course
Ans.	The leave can be granted as per the Ordinance.
Q5.	What is the schedule for marking attendance/forwarding of list of absentees?
Ans.	Attendance/list of absentees is to be marked/forwarded positively till 15th for disbursement by 30th of every month
Q6.	Whether a student who is recipient of Scholarship either through State Government or Central Government sponsored schemes is eligible for grant of PG scholarship?
Ans.	No, the student who is in receipt of any kind of Scholarship/Stipend or salary etc. is not eligible for grant of PG Scholarship.
