This is for information to all concerned that the Undergraduate (UG) students admitted in the academic session 2016-17 or after are eligible for full/partial tuition fee waiver provided their total family income does not exceed Rs. 5 Lakh in the last Financial Year, i.e. 2019-20. In view of that, applications are further invited from the 3rd, 5th and 7th Semester students who could not submit their Family Income Certificate till 15th December as per Notification No. **DSW/Int. 29/20, Dated November 25, 2020**, due to any specific reason. The students, who joined 1st Semester UG Courses in November, 2020 but could not submit their Family Income Certificate till date may also apply. For this purpose, the concerned students must use the link (https://t.ly/WrF4) of the Google Form to fill the requisite information and upload their Family Income Certificate (PDF), issued for the period 1st April 2019 to 31st March, 2020.
