This is for information to all concerned that the Undergraduate (UG) students admitted in the academic session 2016-17 or after are eligible for full/partial tuition fee waiver provided their total family income does not exceed Rs. 5 Lakh in the last Financial Year, i.e. 2020-21. In view of that, applications are invited from the students who will be admitted to 3rd, 5th and 7th Semester students in the Academic Session (2021–22). For this purpose, the concerned students must use the link (https://t.ly/ADrz) of the Google Form to fill the requisite information and upload their Family Income Certificate (PDF), issued for the period 1st April 2020 to 31st March, 2021.
