### Notification for Provisional Admission to M.Tech/MOP/M.Sc. Programme 2020- 2021 through CCMT-2020 & CCMN-2020 & Commencement of Classes

The candidates who have been allotted seat under CCMT 2020 & CCMN 2020 process for provisional admission into M.Tech/MOP & M.Sc. Programme respectively of Indian Institute of Engineering Science and Technology, Shibpur for the academic year 2020-21 are instructed to follow the guidelines as given below:

- As per the Notification No. No. 1816/Exam dt. 26.08.2020 the online registration and personal data entry process shall be continued till 10<sup>th</sup> September 2020 (11.59 p.m.).
- The classes of the Odd Semester (Academic Section 2020-2021) shall **commence from 15<sup>th</sup> September, 2020** through ONLINE mode in place of 8<sup>th</sup> September, 2020 as notified earlier.
- Every registered student shall be provided with G-Suite email ID. For activation of G-Suite ID a registered student shall receive mail in the registered email ID. The student shall have to take action for activation within 48 hours. A student shall be allowed to attend the classes and join in other academic activities through G-Suite ID only. If any student fails to receive any mail regarding activation of G-Suite ID by 13<sup>th</sup> September 2020, he/she must send a mail to the undersigned by 12 noon of 14<sup>th</sup> September 2020.
- For the candidates who have been allotted seats in Special Rounds under CCMT 2020 and CCMN 2020 process for provisional admission into M.Tech./MOP & M.Sc. Programme of this Institute for the academic year 2020-21 respectively the link for registration and entering the personal data shall be made active between 14<sup>th</sup> September 2020 (10.00 am) and 17<sup>th</sup> September 2020 (11.59 p.m.) .
- The student who will register between 14<sup>th</sup> September 2020 and 17<sup>th</sup> September 2020 shall be provided with G-Suite ID as soon his/her registration process including verification will be completed.
