NOTIFICATION

The India Meteorological Department, Ministry of Earth Sciences, Government of India through the press release (on 23.10.2024 at 13:00 Hrs.) has informed that the Severe Cyclone Storm "Dana", a very intense cyclone with associated wind speed of 100-110 kmph gusting 120 kmph is expected to intensify into a storm over northwest Bay of Bengal by early morning of 24th and cross north Odisha and West Bengal coasts between Puri and Sagar Island during night of 24th to morning of 25th October, 2024. There will also be isolated extremely heavy rainfall over Odisha, Gangetic West Bengal on 24th and 25th October, 2024. It has an extensive damage potential which may also affect Howrah District severely. Keeping the above in view, the following advisory is issued in the interest of the campus community.

(a) Don't leave any sharp object loose.

(b) Switch off electrical mains, gas supply during high storm.

(c) Keep doors and windows shut of all rooms of Academic & Administrative Building during high storm.

(d) Remain indoor and don't venture out during high storm.

- (e) Do not park any vehicle near any tree or structure vulnerable to high storm.
- (f) Watch out for broken electric poles, wires, other sharp objects after any high storm.
- (g) All the doors and windows of Halls/Hostels should be secured properly.

(h) Keep torches/candle lights readily available.

- (i) Do not come close to any building/structure like unused Garage block quarters and Barrack type quarters already declared condemned by the Institute.
- (j) Students residing in the hostels should not go out of the hostel and on the roof during storm.
