Steps to be followed:

2. The candidates are required to submit their admission fees to the above mentioned bank and have to produce the fee receipt on the date of physical reporting (17th July,2025). The last date for fee submission is 15th July, 2025 (upto 11.59 p.m.). After this period no request will be entertained for submission of admission fee. The candidates are advised to check the section 6 of the information brochure to know the eligibility criteria.

All candidates shall be required to compulsorily report to the Institute on 17th July, 2025, between 11.30 am to 3 pm at Office of the Dean (Academic) for physical verification of all documents and along with the payment receipt for enrolment in the MBA Programme.

- 3. The enrolment certificate shall be given on the basis of document verification and successful submission of payment receipt. Any candidate fails to report to the Institute on the above mentioned date shall not been rolled in MBA Programme even if he/she has paid the fees.
- 4. Date of commencement of the classes shall be notified shortly.
