Notification for Provisional Admission to Ph.D. Admission December Cycle 2020 (for Sponsored Categories)

This is to inform that the final list of selected candidates along with waiting list for admission to Ph.D. programme in December Cycle 2020 has been published in the Institute website on 25th June 2021.

The candidates (for Sponsored Categories) selected for admission (provisionally) in the Ph.D. program of December Cycle 2020 are required to follow the following steps.

Steps to be followed:

1. The candidates are required to register and enter their personal data in the following Google form link. This link shall be active between **1st July 2021 (from 4.00 pm) to 5th July 2021 (upto 11.59 am)**. After this period no request will be entertained for registering and entering the personal data. The candidates are advised to check the section 5 of the information brochure to know the eligibility criteria.

The list of Original Documents / Certificates which needs to be uploaded for provisional admission is as given hereunder:

- i) Physically signed scanned copy of the online submitted application form.
- ii) Scanned copy of mark-sheets certificates of the following academic degrees
 - a) Secondary (10 level),
 - b) Higher Secondary (10+2 level) / Diploma in Engineering,
 - c) Under Graduate (B.E./B.Tech./B.Arch./B.Sc./B.A. etc.),
 - d) Post Graduate (M.E./M.Tech./M.Arch./M.Sc./M.A./MBA etc.).
- iii) GATE/NET/DST Inspire score card / award letter; if applicable.
 - [Regular candidates with Institute Fellowship category : (i) must have completed Master's programme in Engineering / Technology/Architecture with GATE fellowship or (ii) must have qualified GATE/NET for Science/Humanities/Management discipline]
- iv) Proof of Date of Birth.
- v) Blood Group Certificate.
- vi) Category Certificate (if applicable) and PWD certificate (if applicable) from a competent authority.
 - [OBC-NCL/EWS certificate issued on or after April 1, 2020 will be accepted during online document verification. However, admission offered, if any, will be provisional, and subject to submission of OBC (NCL)/EWS certificate issued on or after April 1, 2021 at the time of physical reporting in the Institute].
- vii) Self declaration for any discrepancy found as per attached format.

viii) No Objection Certificate (NOC), in the proper format (Sponsored Candidates: Category A or Category B, as applicable, as given in Ph.D. Information Brochure – December Cycle 2020, page 19-22).

2. The relevant documents shall be verified. For candidates of Category B, the each case shall be forwarded to the respective departments / centers / schools. The concerned DPGC shall verify the availability of research facilities and co-supervisor at the sponsoring organization.
3. The successfully verified candidates (both Category A and Category B) shall get information from the institute at their email.
4. Only successful verified candidates who will be informed through email have to pay Rs.17,500.00 (Rupees Seventeen thousand and Five hundred only) as Institute Fees for this semester. The candidates are advised not to make any payment till verification emails are received. The above fees for admission into Ph.D. programme for this semester has to be deposited through online as per the following details in the stipulated time period:

5. After payment of fees, candidates shall have to upload bank transaction details and the filled in and signed admission form through the 2nd Google form link. This Google form link and the admission form shall be furnished along with the verification email.
6. The provisional enrolment certificate shall be given on the basis of online document verification, successful submission of payment receipt and filled in and signed admission forms. Candidates will get Provisional Enrolment Number by the Office of the Dean, Academic, subsequently.
7. The doctoral programme shall start on successful submission of payment receipt and filled in and signed admission forms.
8. Each candidate shall have to upload the option form for supervisor allotment through 3rd Google form link. The Google form link shall be sent to each candidate along with the format of option form. The candidate has to mention the broad area of research interest and option of three supervisors according to the rank of preferences. It is to be noted that the Department / School / Centre, shall allocate the supervisor on the basis of the option given by the enrolled candidate and the field of research interest of the candidate as well as the availability of potential supervisors. While allocating the supervisor, due weight shall be accorded to the preference expressed by the scholar.
9. Once situation will improve, students shall be allowed to enter in the campus. The final physical document verification shall be carried out and admission shall be confirmed.
10. The dateline for different actions to be taken by the candidate shall be intimated in due course. For detailed schedule please refer Annexure–I.
