The Ramanujan Central Library, Indian Institute of Engineering Science and Technology, Shibpur invites sealed tender from reputed vendors for supplying, fitting and fixing of false ceiling of the Room of the Librarian (approx. size 28'×18') with ceiling mount square LED light fittings fixing, etc. – all complete. Last date for submission of tender to the office of the Ramanujan Central Library, Indian Institute of Engineering Science and Technology, Shibpur, is March 6, 2018 latest by 2.00 P.M.

Name of the work – Supplying, fitting and fixing of false ceiling of the Room of the Librarian (approx. size 28'×18') with ceiling mount square LED light fittings fixing, etc. – all complete.

TECHNICAL SPECIFICATIONS:

Supplying, fitting and fixing of false ceiling framework with powder coated exposed G.I. grid suspension system (E-Grid U-1520 or equivalent load carrying capacity with mid span deflection not exceeding 1/360 span with hanger spacing of 1200 mm c/c) consisting of Main Runner 3600 mm long, Cross Tee 1200 mm/600 mm long and Wall Angle. The Wall Angle shall be fixed on PVC Dash Fasteners on the perimeter of the wall by steel screws with distance 300mm c/c. The Main Runners to be placed @ 1200 mm. The Cross Tee 1200 mm will be inserted in the pre-cut slots of Main Runner at a regular interval of 600 mm to form a modular grid of 1200 mm X 600 mm. Additional Cross Tees of 600 mm shall be placed perpendicular to the Cross Tee 1200 mm long to finally form a grid of 600 mm X 600 mm. Grid of module size 600 mm X 600 mm shall be supported by 6 mm dia G.I. wire from purlins/soffit – all complete.

Supplying, fitting & fixing High Pressure steam Cured Non Asbestos fibre cement designer ceiling board (Density > 1300 Kg per Cu.m.) of size 595mm X 595 mm conforming to IS 14862 and type B, category III of ISO 8336, tested as per AS-1530 Part 3 and BS-476 Part 4,5,6,7 & 8, should be placed in the Grid module to form a false ceiling. False ceiling with (i) 4 mm thick Fibre Cement Standard ceiling board – all complete.

Ceiling mount square LED light fittings fixing of size 495 mm × 495 mm with 4 nos. 18 W LED, shape – square, make – Philips or equivalent



TERMS AND CONDITIONS:

- h) Payment will be made within 60 days of Submission of proper bills; challans etc. by A/c. payee cheque. No Cash payment will be made under any circumstances.
- i) INITIAL SELECTION OF TECHNICALLY RESPONSIVE BIDDERS WILL BE DONE PURELY BY SCRUTINISING ESSENTIAL TECHNICAL DOCUMENTS WITH RESPECT TO THE VARIOUS QUALIFICATION CRITERIA SPECIFIED IN THE TENDER RESTS authority will evaluate the financial bid (the gross amount i.e. inclusive of all taxes, other charges etc.) of the responsive bidders only. IEST authority reserves the right to select L1 vendor on the basis of verification of calculations of price quoted by the technically responsive bidder.
- j) Based on our specifications, Manufacturers (OEM) catalogues of items are to be provided with Model Name/No. (if applicable), detailed specification and Brand with the quotation, without which quotation will not be considered.
- k) In case of non-supply of material/non-execution of work within the due date the Director, IEST Shibpur will have the right to impose penalty like forfeiture of performance security and removal of the name from the list of the vendor and resort to risk purchase in full or part thereof at his/her discretion, his/her decision shall be final.
- l) Scanned Copy of similar type of order received from any other similar Educational Institute, during the last one year, must be submitted for credential.
- m) All the equipment and accessories will carry a warrantee for a period of 36 months from the date of commissioning. Warranty for all the items supplied will be on 'all comprehensive' basis, i.e., including repairs, replacements, maintenance etc. Calibration/Test Certification must accompany along with the equipment. Supply of equipment shall including installation, erection, commissioning and demonstration.
