Order

At present the Institute is charging monthly electricity bill from the occupants of the quarters/premises used by other organisations on the basis of the office Order No. RMS/6090/17 dated 02.08.2017 based on the tariff scheduled of CESE w.e.f. 01.04.2014

Since CESC revised the Electricity Tariff from time to time since 2004, Institute has decided to revise the electricity charges as per the prevalent rate of CESC tariff for domestic user w.e.f. 01.04.2019.

Tariff of electricity charges as per the tariff of CESC vide their order dated February 3, 2022 Rate G (Domestic Urban) for the year 2019-20 is as follows:

The new tariff for the consumers will be charged by the Institute immediately with effect from 01.09.2022 and the arrear dues for the period between 01.04.2019 and 31.08.2022 will be realized from the consumers in five equal installments.

A committee has also been formed for short recovery of electricity charges as pointed out by the CAG Central Audit team. This committee will suggest the methodology for recovery of electricity charges since last revision (vide office order no. RDO- 2/2876 dt. 07.04.2005) till 31.03.2014 and a policy for fixing the tariff of monthly electricity bill for the occupants of the quarters, banks, schools, canteens, ITI, PWD Offices etc. within the campus. On submission of their report the authority will decide on recovery of electricity charges since last revision until 01.04.2014.
