Subject:- Clarification regarding applicability of Dearness Relief / Dearness Allowance in settlement of pension, gratuity and leave encashment in respect of employees of Indian Institute of Engineering Science and Technology (IIES, Shibpur under Statute 28 (iii) – regarding.

Sir,


I am directed to refer to the Institute's communication dated 27.05.2025 on the subject cited above and to state that the matter was referred by this Ministry to the Department of Pension & Pensioners' Welfare (DoP&PW) for seeking clarification on the issue **(copy enclosed)**.

2. DoP&PW, vide its O.M. dated 22.09.2025 **(copy enclosed)** has clarified that in respect of employees of IEST, Shibpur covered under Statute 28(iii), Central Dearness Allowance (DA) and Dearness Relief (DR) rates shall apply for the purpose of calculating pension.

3. Further, it has been clarified that for the purpose of calculating gratuity and leave encashment in respect of employees of IEST, Shibpur covered under Statute 28(iii), Central DA shall apply.

4. This issues with the approval of the competent authority.

OFFICE MEMORANDUM

विषय : Seeking Clarification regarding Pension, Gratuity, and Leave Encashment for Employees of IEST, Shibpur, under Statute 28(iii)-reg.

The undersigned is directed to refer to Ministry of Education, Department of Higher Education's ID Note No. 32-512025-TS.III dated 12.08.2025 received with e-file no.32-5/2025-TS.III /11062 dated 19.08.2025 on the subject mentioned above.

2. In this regard, the comments of the DoPPW with respect of 28 (III) of **IEST Statute** are as under :-

Query 1. Pension Calculation:

- a. **The Problem:** The pension is to be based on the last drawn pay (Central Government pay scale), but there is no clear instruction on which Dearness Relief (DR) rate to apply: **t h e Central Government DR (55%) or the State Government DR (18%).**
- b. **The Clarification Needed:** How should the pension be computed? Should the DR of the Central Government or the State Government be used?


Ans - It has been observed from para 3.3 of the ID note that these employees were/will be earning pay as well as DA of the Central Govt, being employees of IEST, Shibpur, a Centrally Funded Technical Institute hence the DA the rate of 55% should apply.

Query 2. Gratuity and Leave Encashment Calculation:

- a. **The Problem:** Gratuity and leave encashment are to be calculated based on the last drawn pay plus the admissible Dearness Allowance (DA) on the date of retirement. Since these employees were drawing Central Government DA at the time of retirement, it is unclear whether this DA or the State Government's DA should be used for the calculation.
- b. **The Clarification Needed:** How should gratuity and leave encashment be calculated? Should the DA of the Central Government or the State Government be considered?

Ans :- As per CCS (Pension) Rules, Gratuity is calculated based on the last drawn pay plus the admissible Dearness Allowance (DA) on the date of retirement. There is no specific rule under Gratuity Rules for such cases. However, the employees of IEST were drawing Central Government DA at the time of their retirement. The emoluments are calculated as per 31 and 32 rules of CCS (Pension) Rules, 2021. Hence, the same should apply for calculation of their gratuity. The terms and conditions of their absorption / conversion of department may also be taken into account. Hence, it is clarified that on the last day, these employees were/will be earning pay as well as DA of the Central Govt, being employees of IEST, Shibpur, a Centrally Funded Technical Institute. Hence the DA the rate of 55% should apply.

3. This issues with the approval of the competent authority.
