- g) In case of PWD candidates, certificate from competent authority, (if applicable) as per GoI rules to be produced.
- h) Reference letters endorsing the candidature, if any, in sealed envelopes.
- i) Any other relevant document in support of candidature.

The Institute will not consider any request for extension of time for submission of above mentioned documents during physical documents verification before the interview. Failing to produce above documents, the candidates will not be permitted to appear for Interview.

- 4. The candidate having objection about their ineligibility may submit in writing with all supporting documents to the Registrar, IIEST, Shibpur through e-mail at recruitment.nonfac@iiests.ac.in on or before November 11, 2024. The Institute will not consider any request beyond the stipulated date.
