This is for information to all concerned that the 1<sup>st</sup> year Undergraduate (UG) students admitted in the academic session 2022-23 are eligible for full/partial tuition fee waiver provided their total family income does not exceed Rs. 5 lakh in the last Financial Year, i.e. 2021-22. In view of that, applications are invited from the 1<sup>st</sup>year UG students in the academic session 2022-23. For this purpose, the concerned students must use the link (<a href="http://bit.ly/3Ed6XqB">http://bit.ly/3Ed6XqB</a>) of the Google Form to fill the requisite information and upload their Family Income Certificate (PDF), issued for the period 1<sup>st</sup> April 2021 to 31<sup>st</sup>March, 2022.
