This is for information to all concerned that the Undergraduate (UG) students admitted in the academic session 2021-22 or after are eligible for full/partial tuition fee waiver provided their total family income does not exceed Rs. 5 Lakh in the last Financial Year, i.e. 2024-25. In view of that, applications are invited from the UG students (except SC/ST/PH) for the academic session 2025-26. Those having certificate validity for more than one year and already submitted their certificate also have to submit their certificate. For this purpose, the concerned students must use the Google Form link https://forms.gle/t2whwfxK6AK9tGos5 to fill in the requisite information and upload their Family Income Certificate (PDF), issued for the period from 1st April 2024 to 31st March, 2025.
