1. Preference will be given to **OEM** or Authorized Agent (document required).
2. The potentials bidders are requested for onsite inspection through HoD during any working day within the due date of bid submission after prior information. An inspection report should be provided.
3. Any further additional cost to be incurred during reassembling of the equipment must be included in the quotation. No such additional cost will be entertained in future.
4. Separate quotations are to be provided for i) dismantling including relocation and reassembling to the new chemistry space, and ii) necessary servicing and repairing charges
5. Bidders are invited to submit sealed quotation as per the technical specifications for tendered item in the Department of Chemistry, **on or before 15 working days from the date of publication of the tender** between **10.30 a.m. to 5.00 p.m.** except Saturday, Sunday and other public holidays. Quotations received later will not be entertained under any circumstances.
6. Date and time of opening of bid is **next working day at 11.00 a.m.** and the place of opening of bid is office Room of the Department of Chemistry, IEST, Shibpur, Howrah-711103.
7. Bidders are to submit the quotations in Sealed Cover to the Department of Chemistry in the following address:

8. The price quoted should be inclusive of all Taxes, duties and levies. Inclusion of Tax/Levy at a later stage will not be accepted. Freight, Insurance charges should be clearly indicated.
9. The work must be done at IEST, Shibpur premises between 10.00 a.m. and 5.00 p.m. The tenderer will be responsible for any breakage, damage or defect in the equipment during relocation detected subsequently. The disassembling, relocation and reassembling of the equipment should be completed within a period not exceeding **two weeks from the placement of the formal work order** failing which appropriate action will be taken as per university rules.

**10.** If the work is not completed within the stipulated period as indicated in the Work Order, a Liquidated Damage @ ½ per cent per week will be imposed subject to maximum of 5% of the value of work order.

**11.** Bills in triplicate should be presented for payment within 15 days of Supply / Completion of work. No Advance Payment can be made. All bills are to be accompanied by Order copies and Challan Receipt. The Order Number is to be noted on both the Challan and the Bill.

**12. Documents to be submitted with the tender:**
