2.Service Tax

Tenderer should be registered under GST Act and have a validGST registration number.

3. Time of Commencement of Work

Authorized representative(s) has to be deputed at the institute withinthree (3) days from the date ofwork order to start the work.

4. Submission of Valuation Report

Report with RESERVE SALE PRICE of each and everylot will have to be submitted in a sealed envelop superscribing 'Valuation Report' and Institute letter reference within twenty one (21) days from date of work Order copy.

5.Payment

Payment will be made within three (3) months after submission of Valuation Reportsubject to completion report from the Institute authority.

6. Breach & Termination

If there is any breach of contract on the part of successful valuer, institute reserve the right to initiate appropriate action for termination of contract and business banning. 7. Rejection of Tender
