## **NOTICE**

This is for information to all concerned that the Undergraduate (UG) students admitted in the academic session 2021-22 (for B. Tech.) and 2020-21 (for B. Arch.) or after are eligible for full/partial tuition fee waiver provided their total family income does not exceed Rs. 5 Lakh in the last Financial Year, i.e. 2023-24. In view of that applications are invited from the 2<sup>nd</sup>, 3<sup>rd</sup>, 4<sup>th</sup>, 5<sup>th</sup> year (B. Arch) students (except SC/ST/PH) for the academic session 2024-25. Those having certificate validity for more than one year may apply for academic session 2025-26, 2026-27 and 2027-28, as per validity of Family Income Certificate. For this purpose, the concerned students must use the Google Form link (<a href="https://forms.gle/A64JdF2jhDP5mjGJ7">https://forms.gle/A64JdF2jhDP5mjGJ7</a>) to fill in the requisite information and upload their Family Income Certificate (PDF), issued for the period 1<sup>st</sup> April 2023 to 31<sup>st</sup> March, 2024. On verification of the Family Income Certificates, the Tuition Fees waiver for the Odd and Even Semester (Academic Session 2024 – 2025) will be granted to the eligible students as per rule.

No request for Tuition Fee Waiver will be considered after the specified date (mentioned above).
