Young Faculty Research Award 2022 (YFRA-2022)

A. Announcement

Alumni Cell, IIEST, Shibpur is announcing the annual Young Faculty Research Award (YFRA) for the year 2022 patronized by the IIEST Alumni Association Washington Metro Area (IIESTAA-WMA) and GAABESU Shibpur Foundation, USA. All faculty members, serving in regular posts at IIEST, Shibpur and meeting the following criteria are eligible to apply.

B. Application Eligibility Criteria

Essential

- The applicant is not older than 40 years as on 31/12/2022.
- · The applicant has not received this award earlier in any form.
- The applicant has been a faculty member in a regular post at IIEST, Shibpur in full time service for at least two years as on 31/12/2022.
- Minimum qualification of the applicant: Ph.D.
- The applicant has to submit his/her <u>SIX</u> best peer reviewed publications in academic journals of international repute, according to his/her choice, out of which he/she must be the First/Corresponding Author of at least <u>FOUR</u> such publications. The publications must have taken place during the calendar years 2018, 2019, 2020, 2021, and 2022.

Desirable

 The applicant may submit a maximum number of five best conference publications of his/her choice with him/her as the First/Corresponding Author.
 Conference publications will not be used towards meeting the qualifying criterion, but may be considered in the overall evaluation of the applicant at the discretion of the Selection Committee.

C. Number and Value of the Award:

There will be one award of US \$3000.00 only (approximately, INR 250,000 only). In case of very close performances by more than one applicant as recommended by the selection committee and duly approved by the competent authority of the Institute, the award of US \$3000.00 will be equally divided between them.

D. Selection for the Award

The two-stage selection will be primarily based on the SIX best research publications as chosen by the applicant in internationally reputed peer-reviewed journals in the applicant's area of specialization during the calendar years 2018, 2019, 2020, 2021 and 2022.

If the selection committee decides that none of the eligible applicants meets the high standard expected of YFRA winners, it may recommend that the award be skipped for the year 2022. Conference publications may be taken into account for selection at the discretion of the selection committee.

<u>Selection Committee</u>: The two-stage selection will be done by distinguished academicians/researchers of various Indian academic/research Institutions of repute, duly approved by the competent authority of this Institute.

<u>Selection Criteria</u>: Quality of the peer reviewed journal in which the applicant's research publications have been published, and the originality/contribution of the published papers will be the primary selection criteria. However, the selection committee, based solely on its own discretion, may consider publication quality in conferences, factors like emerging and important new fields of research.
