CCMT–2022 & CCMN–2022**

The candidates who have been allotted seat under CCMT 2022 & CCMN 2022 process for provisional admission into M.Tech./MOP & M.Sc. Programme respectively of Indian Institute of Engineering Science and Technology, Shibpur for the academic year 2022–23 are instructed to follow the guidelines as given below.

All the candidates must be present during the physical verification of documents cum registration to be held during 8<sup>th</sup> August –12<sup>th</sup> August 2022.

The physical verification cum registration will be conducted between 08/08/2022 to 12/08/2022 (from 11 AM to 3.00 PM).

**NOTE:**

14. Self declaration for any discrepancy found (Format attached).
