Item No.1/1 Presentation by the Director

Item No.3 Admission of Students for the Academic Session 2015-16

Resolution No.3.1

The Senate noted the letter issued to the Director, NIT, Patna (coordinating Institute), regarding the final seat matrix for admission of students to 5 year Dual Degree (B.Tech-M.Tech) and 5 year B.Arch Programs The senate also noted that seat matrix has been finalized after considering Council of Architecture recommendation.

The Senate also noted the report of the Exam Reform Committee placed by Prof Kalyan Bhar regarding study on the similar 5-year integrated Master's Program being offered at premier institutes including IIT Kharagpur, IIT Kanpur, IIT Madras, IIT Mumbai, IIT Delhi and NIT Rourkela. The Committee also consulted curriculums of renowned institutes like University of Illinois, University at Buffalo, Stanford University, and University of Alberta etc. in their undergraduate and postgraduate programmes. The findings and the draft structure will be discussed before the next senate meeting. Since the academic programms of the 5 years Dual Degree (B. Tech- M.Tech) will be submitted to the coordinating Authority of JEE (Main) shorty, Director requested the Chairman of the Exam Reform Committee to submit their recommendation by 24th February, 2015. The Director has also requested all the departments to prepare the appropriate course contents/syllabi to be offered, at the earliest so that the entire details can be framed immediately once the course structure is accepted by the Senate.

Item No.4 Academic Calendar for the year 2015

Resolution No.4.1

Resolved that Academic Calendar placed to the members be approved with minor changes.

Item No.5 Publication of Results

Resolution No.5.1

Resolved that UG and PG results should be published in due time. It is decided that for smooth functioning of the Examination Department, two Technical Assistants will be recruited.

The Senate also noted that the Result of ME (Regular, Odd Semester 2015) in Civil Engineering are yet to be published due to non availability of marks of CE907 in a defined format (70 as Theory Marks and 30 as internal assessment). It has been resolved that the Director will finalise the matter in consultation with the Head, Civil Engineering Department, so that total marks of that paper CE907 will be divided with respect to the above format i.e out of 70% and 30% respectively and accordingly it will be submitted to the Examination Section.

Regarding CNC the Senate approved the following:

- 1. A special supplementary Examination will be conducted for all CNC students to allow them to sit for the Exam as a special case through which they can get a chance to clear their failed papers. It will be strictly mentioned that the students will be given the last chance to clear their paper/papers for which they have been called as CNC. If they are able to pass the paper/papers then all the readmission will be taken in the odd semester as per Institute existing examination regulation.
- 2. Ms. Kakoli Sai, a PG student failed 1st semester and will be allowed to clear her fail papers through a special supplementary examination to be conducted during this even semester (January June 2015) and in the case she is able to clear failed papers, she will be allowed to take admission in the 2nd semester during this even semester (January June 2015) and to continue in the session January-June 2015.

Misc Agenda 8.1: To consider the appeal of Sri Dipankar Chakroborty, Assistant Controller of Examination to exempt from written test for Ph.D Admission

Resolution: The Senate decided that the matter should be dealt with as per Rules.

Misc Agenda 8.2: To fix up norms for granting Institute Fellowships to the candidates who are pursuing their PhD work and have been getting scholarships from TEQIP /other sponsored projects but the scholarships have been terminated/ discontinued before completion of work.

Resolution: Members opined that a uniform guideline for fixing norms for granting Institute fellowship is necessary to maintain transparency.

Resolved that, priority would be given for granting Institute Fellowships (MHRD) as a support to such candidates who are pursuing their PhD work and whose scholarships from TEQIP /other sponsored projects have been terminated/ discontinued. The GATE/NET qualification is not mandatory for such candidates. Such candidates should apply afresh to the Director, IIEST for Institute Fellowship/ financial support through the Head and the ex-officio Convener, Doctoral Committees of the department, giving details of existing scholarship status and progress of work. Selection of such candidates of a department for Institute Fellowship and its tenure will be decided solely on recommendation of the Doctoral Committee. In no case the tenure for such students should be more than two years. The fellowship would be granted only to those whose scholarships has been terminated. If in the process, any of the existing scholarship is extended by TEQIP or the funding agency, the selected candidate should stick to his/her old scholarship till its termination. The department would send the recommended merit list of selected candidates to the Director for final granting of the fellowship that will take effect from the termination date of old scholarship.
