At the outset, Prof. Parthasarathi Chakrabarti, Chairman of the Senate welcomed the members and explained the necessity of conducting this emergency meeting of the Senate. The Chairman placed the agenda for discussions.

Item No.EM4.1: To Consider the recommendation of the 2nd meeting of the "Senate Standing Committee for Emergent Academic Matters" regarding the following issues:

- 1. The application of Gundelli Shiva Akhil for readmission in 3rd year and appearing in the upcoming supplementary examinations.
- 2. The application of Hrithik Rudra, a Bangladeshi national for reduction of tuition fees.
- 3. The application of students who got CNC in Hydraulics for reappearing the exam.
- 4. The emails sent to the director by Sri Sourav Barua and Ayan Ghosh (CST) who have got year lag for failing in the laboratory subject.
- 5. NOC for transfer of CSIR-NET JRF to HEST Shibpur.

- 6. Application received from M.Tech students regarding disbursement of GATE Fellowship for the month of June 2018.
- 7. Change of branch for students who have successfully completed their 1st year courses.
- 8. The request for re-admission of Sri Nillohit Biswas in the undergraduate program.
- 9. Considered the application of of Sri Anindya Adhikary for continuation of his study in ME.
- 10. Waiver of tuition fees of Sri Mukesh Singh Samant.
- 11. Including the M.Tech. Program in Biomedical Engineering Course in the PG examination rules.

Resolution of the Senate on Item No.EM4.1:

Resolution No.EM4.1.1: The Senate considered the resolution of the 'Senate Standing Committee for emergent matters' regarding readmission of Gundelli Shiva Aklil in 3rd year and appearing in the upcoming supplementary examination. The Senate resolved that he may be allowed to take readmission in 3rd year with the condition that he will have to give an undertaking that he will pay the dues as to be decided by the Institute and his result in the odd semester examinations held in November-December 2017 will be declared null and void. The Senate also resolved that Gundelli Shiva Aklil shall also be allowed to appear in the upcoming supplementary examinations. Regarding his appeal for financial matter, the Senate resolved that it will be looked into by a committee under the chairmanship of Dean (Students Welfare) to be constituted by the Director. The committee shall submit its report to the Director and the decision of the Director will be binding on the student.

Resolution No. EM4.1.2: The Senate considered the resolution of the 'Senate Standing Committee for emergent matters' regarding reduction of tuition fees for Hrithik Rudra, a student from Bangladesh. The Senate resolved that change in tuition fees is not possible for foreign students who have been admitted earlier with tution fee of \$3000 per year as per the decision of the Institute Authority. The fees for such students will continue to be \$3000 per year. The senate also resolved that the Dean (Academic) will submit a proposal to the Senate to revise the fee structure of the foreign students after comparing the fee structure of foreign students in NITs and the cost incurred by the Institute for such students. The recommendation of the Senate on this issue will then be placed before the Finance committee and BOG for consideration and approval.

Resolution No.EM4.1.3: The Senate considered the resolution of the 'Senate Standing Committee for emergent matters' regarding reappearing in supplementary examinations of the students who have been declared as CNC in Hydraulics. The Senate resolved that the six students who appeared in special supplementary examinations held in the even semester 2018 and again declared as CNC, will be given a last chance to appear in the special supplementary examinations in 'CNC' marked paper/(s) (along with the supplementary examinations to be held in August 2018). Based on their successful result in the said examination, these students will be allowed to continue their studies. The Senate also resolved that remedial classes on that subject will be arranged for these students by the concerned department, i.e. Dept. of Aerospace Engg. & Applied Mechanics before appearing in the supplementary examination.

The Senate also resolved that the students who have been declared as 'FAIL' second time in the semester examinations of the same year and became 'CNC', will also be allowed to take readmission in the preceding odd semester during 2018-2019 session as a last chance and will continue their study.

Resolution No. EM4.1.4: The Senate considered the resolution of the 'Senate Standing Committee for consideration of the applications of Sri Sourav Barua and Sri Ayan Ghosh of CST Department who have got year lag for failing in the laboratory subject. The Senate resolved that they will be allowed to appear in all theory and sessional papers of 6th semester examinations along with the supplementary examinations to be held in August 2018. The

Senate also resolved that all such students who have more than 75% attendance in the laboratory classes and have got year lag for failing in the laboratory subjects may also be allowed in the semester examinations along with the supplementary examinations to be held in August 2018, if they applied for such concession.

The Senate also resolved that the students who have been declared as 'FAILED' will be allowed to carry forward their marks of passed papers (Theory and Sessional) with the approval of the Dean (Academic) and recommendation from the concerned HOD, provided they take readmission in the preceding odd semester,.

Resolution No. EM4.1.5: This Item was dropped.

Resolution No. EM4.1.6: The Senate considered the resolution of the 'Senate Standing Committee for emergent matters' regarding disbursement of GATE fellowship for the month of June, 2018. The Senate resolved that scholarship will be given to each student till completion of the course as per the Institute schedule.

Resolution No. EM4.1.7: The Senate considered the resolution of the 'Senate Standing Committee for emergent matters' regarding change of branch for students after successful completion of their 1st year classes. The Senate resolved that such inter disciplinary changes should be incorporated in the UG Ordinances by framing relevant rules for implementation for the next academic session. However, the branch change for the current session be carried out as per notification of Dean (Academic).

Resolution No. EM4.1.8: Considering the resolution of the 'Senate Standing Committee for emergent matters', the Senate resolved that after receiving mentally fit certificate from the doctor, the re-admission appeal of Sri Nillohit Biswas of ETC Department may be considered by the Dean (Academic).

Resolution No. EM4.1.9: The Senate considered the resolution of the 'Senate Standing Committee for emergent matters' regarding disapproval of continuation of study in ME of Sri Anindya Adhikary and the Senate endorsed the resolution of the Senate Standing Committee.

Resolution No. EM4.1.10: The Senate considered the resolution of the 'Senate Standing Committee for emergent matters' regarding waiver of tuition fees of Sri Mukesh Singh Samrat. The Senate resolved that the matter will be examined by a committee under the chairmanship of Dean (Students Welfare) to be constituted by the Director. This committee will submit its recommendations to the Director. Based on the recommendations of the committee, the Director will take the decision regarding waiver of tuition fees of Sri Mukesh Singh Samrat. The Senate further resolved that the student will be given a chance to appear in special examination on the condition that decision of the Director regarding waiver of tuition fee will be binding for the student.

Resolution No. EM4.1.11: The Senate considered the resolution of the 'Senate Standing Committee for emergent matters' regarding incorporation of the M.Tech Programme in Biomedical Engineering Course, started in the Academic Year 2016-17, in the PG examination rules of the Institute. The Senate resolved that M.Tech in Biomedical Engineering will be included in the existing PG Examination rule of the Institute. The Senate also resolved that the result of final semester of this course be immediately be published as per the PG examination rule.

Item EM4.2. To consider the appeal of students namely i) Mrinmoy Deka, B. Tech. 2nd Yr. Civil Engg. Dept ii) Mrinmoy Maity, M.Sc., Mathematics Dept and iii) Biplab Das, M. Sc., Mathematics Dept for reducing the tuition fees.

Resolution EM4.2: The Senate considered the appeals of the students and resolved that their cases be sent to the Committee constituted by the Director as per Resolution No. EM4.1.10. The



Senate further resolved that this committee will also recommend about the resources for the Student Welfare fund of the Institute and how this fund be utilised for the benefits of the economically weaker students.

Item EM4.3. To consider the appeal of Hillol Maity, B.Tech. 4th Yr. ETC student for tuition fee clearance.

Resolution. EM4.3:

The Senate refer this matter to the committee constituted by the Director as per Resolution No. EM4.1.10 under the chairmanship of Dean (Student Welfare) and the committee will submit its recommendation to the Director. The Senate also resolved that henceforth all such cases be sent to the committee and on the recommendation of the committee, the Director will take the final decision in this regard.

Item EM4.M1. To consider the appeal of Susanta Saha, student, MSC, Chemistry Dept for waiver of tuition fee.

Resolution EM4.M1:

The senate considered the appeal and resolved that his application be sent to the committee constituted by the Director as Resolution No. EM4.1.10 for such purpose.

Item EM4.M2: To consider the Academic calendar of the Odd semester.

Resolution EM4.M2:

The Senate considered the academic calendar of the Institute submitted by the Dean (Academic) and after detailed discussion the Senate approved the enclosed academic calendar for the Odd semester. The Senate also resolved that henceforth the Convocation of the Institute shall be held on the last week of December and this year the date is fixed on 23rd December, 2018.

The Senate resolved to initiate actions as per the decisions on the above items immediately pending confirmation of the proceedings of the 4th Emergency Meeting of the Senate.
