At the outset, Prof. Parthasarathi Chakrabarti, the Chairman of the Senate welcomed the members and explained the necessity of conducting this emergency meeting of the Senate. Then the Chairman requested the Registrar to place the agenda for discussion. Before placing the agenda, the Registrar mentioned about

the emails he received from the Senate members regarding this emergency meeting and also explained that as per the Statutes of the Institute [Statute 5 (7)], an emergency meeting can be convened to consider urgent special issues. Thereafter, with the permission of the Chairman, the Registrar requested the Dean (Faculty Welfare) to explain the agenda to the senate member for discussion. Prof. Bichitra Kumar Guha, Dean (Faculty Welfare) explained in detail about the two agenda on faculty recruitment based on the AcoFAR report and also explained the recent MHRD order for category wise SC/ST/OBC reservation rules for faculty recruitment. On the request of Dean (Faculty Welfare), Prof. B.K. Ghorai, Professor, Dept. of Chemistry and Chairman, Reservation Cell & Liaison Officer for SC/ST/PWD IIEST, Shibpur explained the present reservation rules in respect of 14 point roster and 200 point roster.
