Item No.15.03 To consider the Report of the Prof. Hafizur Rahaman Committee for revision of pay of the contractual employee.

## Resolution No. 15.03:

The Committee considered the report of Prof. Hafizur Rahaman Committee for revision of pay of the contractual non-teaching employees and advised to place the report in the meeting of the Board of Governors with detailed financial implication for consideration and approval of the Board of Governors.

The recommendation of the Finance Committee shall be placed before the Board of Governors in its 24<sup>th</sup> meeting held on 16.11.2022 for noting and approval.

Item No.15.04 To resolve the payment related issue of the M/s. Das Enterprise for supply of man power for routine maintenance of electrical work.

#### Resolution No. 15.04:

The Committee considered the payment related issue of M/s. Das Enterprise for supply of manpower for routine maintenance of electrical work and suggested that since the financial implication is within the financial power of the Director as per Delegation of Financial Power as approved by the Board of Governors, so the Director may given approval in this regard.

Item No.15.05 To consider the revision of pension of 22 pensioner/family pensioner of the Institute who retired on or before transformation of BESUS to IIEST.

## Resolution No. 15.05:

The Committee considered the revision of pension cases of 22 pensioners/family pensioners of the Institute who retired on or before transformation of Bengal Engineering and Science University, Shibpur (BESUS) to Indian Institute of Engineering Science and Technology, Shibpur (IIEST). The matter was discussed in detail.

The member represented from the Ministry of Education pointed out the provision under Clause 28 of 1st Statute of IIEST where it was stated that: "the Central Government shall assume the liability of pension in respect of those employees who retire after conversion of erstwhile Bengal Engineering and Science University, Shibpur to the Institute and after takeover the existing employees of the Institute shall be given options regarding their service conditions and accordingly the pension liabilities shall be as under:

(i) The liability for payment of existing pensioners covered under State Pension Rules shall continue to be on the State Government. However, the liability for payment of pension for such employees who shall superannuate after the date of conversion of Bengal Engineering and Science University, Shibpur to the Institute will vest on the Central Government."

The member representing the Institute clarified the above provision of Statute and mention that as per NITSER Act, 2007, Clause 5(A)(c) – "all the rights and liabilities of the Bengal Engineering and Science University, Shibpur shall be the rights and liabilities of the Indian Institute of Engineering Science and Technology, Shibpur." Moreover, as per Statute, State Government taken the liability for payment of pension to the pensioners who retire before conversion and belongs under State Pension Rules. But the 22 pensioners as stated above are all the pensioners of the then BESUS (an Autonomous Institute of State Government) and therefore the liability of payment of pension vest on the BESUS and after conversion on IIEST. Presently they are drawing pension (unrevised) as per State Pension Rules. Therefore, the Committee may adopt the G.O. vide No.175-Edn(U)/EH/1U-10/2020 dated 14.02.2022 for revision of their pension/family pension.
