Item No.23.02: Action taken report on the Minutes adopted in the 22ndMeeting of the Board of Governors. Resolution 23.02

Resolution 23.07.(iii)

The BoG considered the recommendation of the Finance Committee and approved the payment of Rs.12,99,375/-out of DST Grant to M/s Bruker India Scientific Pvt. Ltd. against supply & refilling of Liquid Helium in NMR at SAIF Centre of the Institute and advised to pay the AMC Charges out of the resource generated by the Centre or from the IRG of the Institute.

iv) To consider the recommendation of the B&WC for administrative approval and expenditure sanction of the BoG regarding preliminary estimates of Rs.29.40 Cr. towards the following proposed construction under the Scheme of Economically Weaker Section (EWS):

-Construction of (G+5) Building for Structural Engineering / Geotechnical Engineering/ Traffic Engineering Laboratory and Classrooms under Civil Engineering Department.

Resolution 23.07.(iv)

The BoG considered the recommendation of the Finance Committee on the resolution of the B&WC regarding Construction of (G+5) Building for Structural Engineering/Geotechnical Engineering/Traffic Engineering Laboratory and Classrooms under Civil Engineering Department at an estimated cost of Rs.29.40 Cr. submitted by the Executive Engineer, CPWD under the Scheme of Economically Weaker Section (EWS) sanctioned by the Ministry of Education, Government of India and approved.

The BoG also noted the release of 1st installment of grant of Rs.2.94 Cr. by the Ministry vide Sanction Order F.No.36-4/2021-TS.III dated 21.01.2022. The Chairperson, BoG advised that the Director or his representative should meet CPWD officials every fortnight to review the progress of work of all ongoing construction projects for completion of work within the scheduled time frame.

v)To consider and adopt the Separate Audit Report (SAR) made by Indian Audit and Accounts Department, Central, Kolkata, Government of India on the accounts of HEST, Shibpur for the financial year 2020-21.

The BoG considered the recommendation of the Finance Committee and adopted the Separate Audit Report (SAR) for the financial year 2020-21 submitted by the Indian Audit and Accounts Department, Central, Kolkata, Government of India on the accounts of IIEST, Shibpur and para-wise replies thereon.

vi)To report the payment of Retirement/ Death Gratuity to the Mess Employees of the Institute.

Resolution 23.07.(vi)

The BoG considered the recommendation of the Finance Committee regarding the mess employees of the Institute. They had been enjoying only the benefits of Retirement/Death Gratuity since 1981in terms of G.O. No.998-Edn (T) dated 07.12.1981 issued by the Education Department, Govt. of West Bengal. The payments were put on hold after conversion of the Institute to IIEST.

Based on the discussion had with the Ministry by the six-member team of the Institute, the Director sent a mail to the Chairperson, BoG seeking approval for resumption of payment of Retirement/Death Gratuity to 31 retired mess employees. The Chairperson, BoG has given his consent. After retirement, they are not getting any kind of retirement benefits and pension except the above. Till date there are 31 retired mess employees and estimated

liability has been calculated to the amount of Rs.1.43 Cr. The retirement gratuity for 12 employees has already been disbursed.

The BoG approved recommendation of Finance Committee to continue the payment to the remaining retired mess employees so that the payment process should be completed within this financial year.
