At the time of confirmation in the 30th meeting of the BoG held on 05.03.2025, the matter was discussed and it was resolved that the decission as statated above regarding tendering for selecting new banks (nationalzed and private) to operate in the premises by paying charges as per scheduled rates and serve legal notice on the banks for vacating the Institute premises was withdrawn. The BoG agreed to continue with the existing banks with updated agreements as applicable considering their continuous services since decades smoothly.

The BoG considered the recommendation of the Finance Committeerelating to the report of Prof. Hafizur Rahaman Committee for revision of pay of the contractual non-teaching employees of the Institute. After noting the financial implications of Rs. 9.63 lakhs p.m.the BoG resolved to approve the following.
