JU/RO/19/57 dated 11.06.2019; DE/RO/19/104, dt 05.12.2019; & notice on 17.07.2021; Dean(FW)/IIESTS/1/2022; dt.25.02.2022 and (ii) Special Drive for Backlog Reserved Vacancies Advertisement (vide No. RO/SE/21/12 Dated 22.09.2021).

## Resolution 25.01

After a threadbare discussion on opening the recommendations of the Selection Committees constituted for faculty recruitments in various levels of different departments/schools/centres preserved in sealed envelope, the BoG resolved that –

(i)The instruction received from National Commission for Scheduled Castes (NCSC) on 11.05.2023 should be followed. A supplementary advertisement for backlog vacancies be published immediately.

(ii)The Ministry should take initiative to declare the results of the Selection Committees for the recruitment of faculty members within one year from the date of interview (the first interview took place on 22.08.2022) as per clause 23 (13) of the Statute of the Institute.

The Chairperson, BoG directed IIEST administration to complete the process in three months. And also requested MoE to appoint a New Director in two months time.

The meeting ended with a vote of thanks to and from the Chair.
