Item No. 10.05 To consider the introduction of MS programme.

Item No. 10.M3

Resolution No.10.M3:

The Senate welcomed the proposal of Prof. Subhendu Guha, Visiting Professor of the Institute, to establish a gold medal and silver medal in the name of his late son Aveek Guha to promote study and research in Renewable Energy Science and Technology of IIEST, Shibpur. To meet the required expenses of the Aveek Guha Memorial Gold medal Prof. Subhendu Guha proposed to donate Rs. 2 lakhs for creating an endowment fund. He proposed the student placed first in the annual M.Tech. Examination in the Renewable Energy Science and Technology will be given the Gold medal and 2nd position will get the silver Medal. The Senate appreciated the proposal and considering the amount in the endowment fund, the Senate resolved that only Aveek Guha Memorial Gold Medal will be introduced from this year subject to creation of the endowment fund for this purpose and obtaining further donation equivalent to the amount required for the cost of the gold medal for this year.
