# Agenda Item 32.01: To confirm the proceedings of the 31<sup>st</sup>meeting of the Senate held on 3<sup>rd</sup>February, 2022.

**Resolution 32.01:** The draft proceedings of the Senate in its 31<sup>st</sup> meeting held on 3<sup>rd</sup> February 2022 has been confirmed with the following modifications:

For item 31.06, the first two lines "In the 12th Emergency meeting of the Senate held on 6th March 2020 it was resolved that the scholars who have been enrolled under old regulation would continue under new ordinance." be replaced by "In the 12th Emergency meeting of the Senate held on 6th March 2020 it was resolved that the scholars who have been enrolled under old regulation, <u>but registered after July 2019</u>, would be governed by new ordinance."

For item 31.10, It was also resolved that Engineering Departments to make an effort to shift one Departmental Paper of Eighth semester to Seventh semester so that HSS III may be offered in a staggered way in 7th and 8th Semester.

For Item 31.20, the last sentence: "Although it was proposed to issue a separate certificate, but Senate has not approved" be replaced by "Senate also suggested to incorporate suitable changes in the ordinance so that such issue does not arise in future."

Agenda Item 32.02: To confirm the proceedings of the 22nd Emergency meeting of the Senate held on 5th April, 2022.

**Resolution 32.02:** The draft proceedings of the Senate in its 22<sup>nd</sup> emergency meeting held on 5<sup>th</sup> April 2022 has been confirmed.

Agenda Item 32.03: To consider the recommendation of the SUGC and SPGC on mode of conducting end term examination of the even semester courses of AY 2021-22.

**Resolution 32.03**: As per the recommendation of SUGC and SPGC on mode of conducting end semester examination of the even semester courses of AY 2021-22 there was a detailed discussion in the Senate in its 32<sup>nd</sup> meeting held on April 20, 2022. Following norms for assessment of the even semester examinations of AY 2021-2022 have been resolved.

Teachers may conduct Special Make Up test for Mid Semester Examinations.

Full marks of the question paper of End Semester Examination shall be decided by the concerned teacher. However the question paper may be prepared in such a manner so that the length of the answer shall commensurate with the duration of the examination.

Willing students to appear in the online examination using the network facilities of the Institute shall contact the concerned Heads of departments by 2<sup>nd</sup> May 2022. Heads of the departments may arrange suitable place in the department for the said examinations.

# Agenda Item 32.04: To consider the recommendation of SPGC on Seat Matrix and other eligibility criteria for postgraduate admission through CCMT & CCMN.

**Resolution 32.04:** The Chairman Senate requested the Chairman, SPGC to inform the house about the recommendations of SPGC on this item. After the deliberation of the Chairman SPGC, members discussed the issue and resolved the following with respect to the admission through CCMT & CCMN 2022:

- The programme on Safety and Occupational Health Engineering offered by Centre for Healthcare Science and Technology shall be discontinued.
- The programme on Materials Science and Technology offered by School of Advanced Materials, Green Energy and Sensor Systems shall be discontinued
- The intake in the following programme / specialization are to be increased as follows:

- As proposed by Mining Engineering Department, the present PG programme of Mining Engineering shall be replaced by a new programme on Mineral and Energy Resources Engineering without changing the number of intakes (22). The Head, Mining Engineering Department was advised to complete all requirements for framing the course structure and the syllabus for introduction of this new course.
- The intake of M.Sc. programme offered by SOCSAT shall be reduced to 30.
- The intake of the M.Sc. programme offered by Physics, Chemistry and Mathematics shall be increased to 43, 44 and 43 respectively. However, the PG programme of Earth Science will continue with 40 seats.
- The PG programmes of all other departments/schools shall continue with the existing intake.

# Agenda Item 32.05: To consider the appeal of Mr. Arka Sadhukhan (Roll No. 510515073), a CNC Declared student of CST Department to allow him to complete his course.

Resolution 32.05: Mr. Arka Sadhukhan (Examination Roll Number 510515073) of CST Department took admission in 2015.He appeared in 7th semester examination in December, 2019 and obtained back in CS503, CS501, CS623/2, CS601, HU731/1. He did not appear in the Supplementary Examination held in February, 2020 and was declared FAILED in the 8th semester examination held in June, 2020. He was supposed to take readmission in July 2020 in 7<sup>th</sup> Semester for the Academic Session 2020-2021 but he did not take it. As per old regulation (Point No 32, Page 24), a candidate shall not be eligible to seek admission to a given part for more than two consecutive academic session and hence Mr. Sadhukhan was declared CNC for the academic session 2021-2022. The student made an appeal to the Department and DUGC in its meeting held on February 26, 2022 recommended that the student might be given one chance to complete his course. The matter was placed in SUGC in its meeting held on February 28, 2022 and SUGC unanimously recommended the issue for the approval of the Senate. SUGC also recommended that Mr. Arka Sadhukhan might seek readmission in 7<sup>th</sup> Semester for the Academic Session 2022-2023 under old regulation. The resolution of SUGC has been approved by the Chairman Senate. The matter was placed in the Senate and Senate approved it.

Mr. Arka Sadhukhan (Examination Roll Number 510515073) of CST Department has been allowed to take readmission in 7<sup>th</sup> Semester under old regulation for the Academic Session 2022-2023 and also allowed to appear Supplementary Examinations for the failed subjects.

# Agenda Item 32.06: To discuss on allotting teaching assignment to the postgraduate students and research scholars drawing institutional and individual fellowships.

**Resolution 32.06:** The Chairman expressed that the research scholars who are drawing fellowships are supposed to be associated with various teaching activities. They may be engaged in laboratory / practical / sessional / tutorial classes. They may also be involved in assisting teachers in checking answer scripts, conducting class tests etc. In this regard, specific norms may be framed. The postgraduate students, particularly those who are drawing GATE scholarships may also be involved in some teaching assignments. He requested the members to opine on the issue.

The members discussed the matter at length and it was resolved to follow the following norms for arranging teaching assignments for the research scholars and the postgraduate students drawing fellowship.

- M.Tech / MoP students and PhD scholars shall be engaged in Tutorial / Laboratory / Practical / Sessional / Project classes, but not in Theory subjects, to assist the faculty members of the respective classes.
- 1<sup>st</sup> Year M.Tech /MoP students shall be awarded 2-4 hour classes per week. The 2<sup>nd</sup>Sem M.Tech /MoP students and the PhD Scholars shall be engaged for 4 to 6 hours of weekly classes. The scholars who are drawing individual fellowship

• The students/scholars shall also be associated with the supervisors to assist in taking class tests/checking the answer scripts / supervising projects (UG/PG) etc. In addition, they shall be engaged in the invigilation duties during Mid Semester and End Semester examinations.

#### Agenda Item 32.07: To discuss on introducing Post-Doctoral Fellowship programme.

**Resolution 32.07:** The Chairman expressed that most of the institute of higher learning in the country has the provision of Post Doctoral programme. The research activities in the Institute, in general, get enhanced with the involvement of post-doctoral fellows. Presently IIEST Shibpur does not have any provision for engaging Post-Doctoral Fellow. He requested the members to opine on the issue.

After elaborate discussion following are resolved

- The Senate has welcomed the proposal and agreed to introduce postdoctoral programme.
- The modality for selection of Post Doctoral Fellow has to be framed and the selection shall be made centrally controlled system. The draft norms shall be prepared by SPGC.
- Remuneration of the fellows shall not be less than Rs. 55,000.00 per month (consolidated)
- A fellow may be engaged maximum for 2 years with an initial appointment of one year
- The financial issue shall be decided by the Budget Committee and Finance Committee.

#### Agenda Item 32.08: To discuss on a report of the NIRF Committee.

**Resolution 32.08:** An analysis of NIRF 2021 performance of IIEST, Shibpur has been prepared and was placed before the Senate. Prof. Parthasarathi Mukhopadhyay narrated the major findings of this analysis. The members appreciated the analysis and it was resolved that Institute shall take necessary action with respect to the major conclusions of the report.

# Additional Agenda Item 32.09.01:To consider the procedure to calculate CGPA for the courses of a few scholars who have attended coursework including Research Methodology before implementation of the new Ordinance.

Resolution 32.09.01: The Chairman SPGC stated that there are several research scholars who took admission according to old Regulations but due to various reasons could not complete their registration in due time. The 12<sup>th</sup> emergency meeting of the Senate, held on 6<sup>th</sup> March 2020, resolved that these candidates will be given one-time relaxation in the date line for registration. However, candidates registering after July 2019 will be governed by new PhD ordinances. It was also resolved that such students will be allowed to register but they have to complete a 12-credit pre-registration coursework requirement with a minimum of 6.5 CGPA before their pre-submission seminar (resolutions EM 12.2.4, EM12.2.8 and EM12.2.11). It was further decided that the credit points already earned by the candidates shall be considered while calculating 12 credit points. However, the procedure for calculating grades for the course already attended has not been mentioned. The 31st meeting of the Senate resolved to request the SPGC to make recommendations in this matter (resolution 31.06).

The SPGC recommended that before the ordinance came into place the Research Methodology course was a one or two-day course and no mark sheets were issued. Therefore, this course may be considered an audit course, as it is not possible to assign any grade against it. In general, for those students who have completed various departmental postgraduate level courses or dedicated PhD coursework for them a course of 50 marks and 100 marks should assign 2 credits and 3 credits respectively. The grade will be assigned by the Deputy Registrar (Academic) according to the marks obtained by the student following the PG Ordinance.

The Senate unanimously accepted the recommendation of the SPGC.

There being no other item, the meeting ended with a Vote of Thanks to the Chair.
