The Chairman welcomed the members and invitees present in the meeting. The Chairman requested Dean (Academic) to explain the agenda Item No. EM.12.1 and Chairman, SPGC to explain the agenda Item No. EM.12.2 before the members. After detailed discussion the following resolutions were taken by the Senate.

**Item EM.12.1: To consider the note of Prof. Shyamal Shyamal Kumar Chattopadhyay, Chairman SPGC regarding registration of Mr. Somen Adhikary who joined the PhD programme of this Institute on 20<sup>th</sup> July, 2017 with INSPIRE Fellowship having enrolment no. 532017AS09, under the supervision of Dr. Sudipta Kanungo who has left the institute.**

**Resolution No. EM.12.1:**

The Senate considered the note of the Chairman, SPGC and resolved to allow Mr. Somen Adhikary to register for the PhD Programme as per the Ordinances for Doctoral Programme effective from July 2019 of the Institute. The RPEC shall be constituted for the concerned candidate and he is required to clear the comprehensive viva-voce and present the State-of-the-art Seminar. Subsequently he will be issued registration certificate by the Dean (Academic) with effect from the date of completion of the criteria mentioned above. However, the candidate is not required to earn 12 pre-registration Credit points.

**Item EM.12.2: To consider other pending issues regarding PhD students including those who have enrolled PhD programme of the Institute but not yet registered as per the extant rule.**

**Resolution No. EM.12.2.1:**

As mentioned by the Chairman, SPGC, the Senate noted that the list of enrolled/registered candidates circulated among the Senate members is a tentative list (copy enclosed) prepared on the basis of available documents in the Office of the Dean (Academic). The Senate resolved that the concerned HoDs shall examine the list in respect of their respective Departments and in case any name is missing the same may be brought to the notice of the Dean (Academic) with supporting documents for inclusion in the final list.

Thereafter, the Senate discussed and resolved on additional ten (10) items submitted by the Chairman, SPGC regarding the following pending issues of PhD students.

**Item EM.12.2.2: To consider applications for registration of Sandip Moi and Tipu Sultan Haque (Department of Mathematics) who are enrolled provisionally.**

**Resolution No. Item EM.12.2.2:**

The Senate resolved that the two candidates, Sri Sandip Moi and Sri Tipu Sultan Haque, shall be allowed to register as per the Ordinances for Doctoral Programme effective from July 2019 of the Institute. The RPECs in respect of the two candidates shall be constituted and they are required to clear the comprehensive viva-voce and present the

State-of-the-art Seminars. Subsequently, the Dean (Academic) shall issue registration certificates with effect from the date of completion of the criteria mentioned above. However, they are not required to undergo additional coursework before registration. Further, this registration will be provisional until they earn a total of 12 pre-registration credit points maintaining the requirement of minimum 6.5 CGPA before pre-submission Seminar. The credit points, that they have already earned (if any), shall be considered while calculating the total of 12 pre-registration credit points subject to the recommendation of the concerned RPEC. All subsequent procedures shall be guided by the Ordinances for Doctoral Programme effective from July 2019.

**Item EM.12.2.3: To consider the resolution of the Doctoral Committee of Mrs. Kakali Jana Mandal, doctoral scholar registered in the Department of Metallurgy and Materials Engineering for inclusion of Dr. Subhas Ganguly of NIT Raipur as “Co-Supervisor.”**

**Resolution No. EM.12.2.4:**

After detailed discussion on the cases mentioned above, the Senate resolved that the Associate Dean (Academic) shall sort out these cases in consultation with the Dean (Academic), concerned HOD, and the Chairman SPGC following the broad guidelines mentioned below and place the report before the Chairman, Senate through Dean (Academic) for approval.

- a) For candidates who have not registered in due time as prescribed in the extant PhD regulations, a one-time relaxation shall be given by condoning the delay. However, they will be served with an warning to the effect that future any such delay in submission of annual reports and other requirements mandated by the ordinances shall be dealt as per rules.
- b) At least one supervisor must be a regular faculty of IEST, Shibpur.
- c) For candidates working under two supervisors who are not in regular positions in IESTS, one of the supervisors shall be requested to withdraw his/her name and a co-supervisor shall be included from the department in which the candidate has enrolled/registered. However, in case of a school/centre having no permanent faculty, one of the supervisors with exposure in the relevant field shall be chosen from other departments. Selection of this new supervisor shall be made in consultation with the corresponding HOD, the existing supervisors and DPGC convenor by the Associate Dean (Academic) and SPGC Chairman.
- d) A candidate registering after July 2019 shall be guided by the Ordinances for Doctoral Programme effective from July 2019.
- e) The candidates who have not submitted progress reports regularly, should submit all such documents to the Dean (Academic) duly signed by the supervisor(s) and the concerned HOD.
- f) In case of Gargi Saha (Registration No. PhD/R/2014/0039 DTD. 2/6/2014) who is expected to submit her thesis shortly, a third supervisor may be included as a special case.
- g) Extension of registration beyond 5 years shall be granted to those candidates for whom the Doctoral committee has made recommendations for extension. However, as per the extant PhD regulations no extension can be granted beyond 7years of registration.

The Senate also resolved that the Dean (Academic) shall seek an explanation from Ashish Sharma (Enrolment No. 20170154 dated 17/07/2017) regarding the reason behind this inordinate delay on his part in completing the registration formalities.

However, these candidates (excepting in sl. No. 4) shall be allowed to register as per the Ordinances for Doctoral Programme effective from July 2019 of the Institute. The RPECs shall be constituted for the concerned candidates and the existing Doctoral committee shall be dissolved. They are not required to clear the comprehensive viva-voce and present the State-of-the-art Seminars since they have already registered. However, they are required to earn a total of 12 pre-registration credit points maintaining the requirement of minimum 6.5 CGPA before the pre-submission seminar. The credit points already earned by the candidates, shall be considered while calculating the total of 12 pre-registration credit points subject to the approval of the concerned RPEC. All subsequent procedures shall be guided by the Ordinances for Doctoral Programme effective from July 2019.

Keeping in view the resolutions and the broad guidelines stated above, the Associate Dean (Academic), the Dean (Academic) and the Chairman SPGC shall resolve other similar pending cases in consultation with the concerned HOD and the supervisor (s) and place the report before the Chairman, Senate for approval.
