### Matter Arising out of the proceedings of the 6th meeting of the senate:

To note the experts list of different Departments/Schools/Centres approved by the Senate in its 6<sup>th</sup> meeting held on 11<sup>th</sup> February, 2016 submitted by Dean, Faculty Affairs.

Resolution No.07.03

The Senate noted and approved the comprehensive expert lists of different Departments/Schools/Centres submitted by the Dean, Faculty Affairs based on the approval of the Senate in its 6<sup>th</sup> meeting held on 11<sup>th</sup> February, 2016 with the following addition and alternation:

# Item No. 07.04 To consider the proposal of Prof. Anirban Gupta, Local Coordinator-GIAN for conduct of the credit courses under GIAN- a programme of Global Initiative for Academic Networks in Higher Education initiated by MHRD, Goyt, of India.

Resolution No.07.04 Prof. Anirban Gupta, Local Coordinator-GIAN explained the matter to the Senate members in details and the Senate ratified the approval of the director for conduct of the credit courses under GIAN- a programme of Global Initiative for Academic Networks in Higher Education initiated by MHRD, Govt. of India .Thereafter, Prof. Anirban Gupta informed the Senate that they have received three proposals two in the area of VLSI and one on Climate Change. All the proposals have been approved by the Ministry. The course on climate Change will be started on 23<sup>rd</sup> May with 38 registered participants from all over India. The course fee for students will be Rs. 500/- per student, Rs. 5000/- for faculty members and Rs. 20,000/- from industry participants. Duration of the courses is for two weeks. All participant will be given a certificate of participation and a grade card dully signed by the Dean Academic Affairs and the Co-coordinator of the courses.

## Item No. 07.05 To consider the recommendation of the committee constituted by the Director vide Order No. RMS/4769/15 for setting up of Department of Renewable Energy submitted by Prof. Anup Mondal, HOD, CEGESS

Resolution No.07.05 Prof.Anup Mondal, HOD, CEGESS explained the issues related to the setting up of Department of Renewable Energy to the Senate members and after detailed discussion it was resolved that the recommendation of the expert committee formed earlier will be placed before the committee constituted by the Senate, with Dean, Academic Affairs as Chairman for finalisation of the above.

## Item No. 07.06 To consider a request from Prof. Amit Roy Chowdhury, Head, Centre for Healthcare Science and Technology for introducing of 2 year M.Tech course in Biomedical Science and Engineering.

Prof. Amit Roy Chowdhury, Head, CHST explained the matter to the senate members. Prof. Subrata Chakraborty, Professor of Civil Engineering Department opined that some correction is needed in the curriculum and the syllabus. Finally it is resolved that senate has no objection to start this M Tech program from the session 2016-2017 subject to revision of the course structure. The corrected course structure should be submitted to the Dean, Academic Affairs as soon as possible for necessary action. Senate also resolved that for smooth introduction of this course Prof. Roy Chowdhury should discuss the matter with the Dean, Academic Affairs for further course of action.

### Item No. 07.07 To discuss a prayer from Shri Rahul Chowdhury, 4<sup>th</sup> year student of CST Department.

The senate discussed the prayer of Shi Rahual Chowdhury, 4<sup>th</sup> year student of CST Department. Shi Rahual Chowdhury suffered from Dengue and could not appear in the examination due to his serious medical condition and had to sit for supplementary examination. Since as per the existing regulation he will not be entitled to get Honours Degree, he prayed that he may be granted Honors Degree as a special case. After detailed discussion, Senate considered the matter as a special case and also resolved that in future while finalizing the regulation appropriate provision will be made for the students.

#### Item No. 07.08 To discuss the issue of ranking of HEST, Shibpur by the MHRD.

The Chairman informed the Senate that he has written letters to the Hon'ble Minister and the Secretary, MHRD regarding non-incorporation of the institute details, specially the Research and development activities of the institute in the ranking process taken up by MHRD. He also pointed out that if such details were incorporated then the rank of the institute would have surely been much higher.

After a detailed discussion on the issue of ranking of IIEST, Shibpur by the MHRD, the Senate resolved that Director will constitute a committee to look into the shortcomings of the institute in this regard and the committee will recommend the Senate the comprehensive steps to be taken by the institute so that the institute fares adequately well in all aspects to ensure a high position in the NIRF ranking.
