Prof. Ajoy Kumar Ray, Director, IIEST, Shibpur who is also functioning as the Chairperson of BOG as per the section (16) of statute 17 of the First Statute of IIEST, Shibpur chaired the adjourned emergency meeting of the BOG. He first consulted with Mr. Rajan, Under Secretary, Higher Education, MHRD, Govt. of India over phone for organizing this adjourned emergency meeting on the issue of 4<sup>th</sup> Convocation of IIEST, Shibpur to be held on 4<sup>th</sup> March, 2018. After getting concurrence from MHRD, the Chairman then placed the agenda before the members present in the BOG meeting for consideration.
