At the outset the Chairman extended a hearty welcome. Then Senate observed two minutes silence to pay homage to two distinguished retired faculty of the Institute, Prof. Susanta Kumar Sarkar of Civil Engineering Department and Prof. D. N. Roy of Mechanical Engineering Department. Chairman then placed the agenda on Dual Degree (B. Tech. - M. Tech.) mark-sheet issue before the members for discussion.

Resolution of the emergency meeting held on 20th September, 2017

The members discussed all the aspects of the appeal of the students and the note of the Dean Academic Affairs on the issuance of mark sheets of the students. The Senate noted that following the BOG decision to allow the students who have joined B.Tech-M. Tech dual degree programme in 2014 and subsequent years 2015 and 2016, to give an option of exit to those who desire to pass out with only B. Tech degree programme after completion of 8 semesters, the Institute has permitted the students (list appended) to complete B. Tech (4 year) degree programme, after successful completion of their studies. The Senate also noted that from the academic session 2017-18, Institute has admitted students only in 4 years B. Tech programme with an option to join integrated 5 year B.Tech.-M.Tech. programme, which will be allowed based on their academic performance.

Regarding the issuance of mark sheets of the students who have opted for exit to complete their B. Tech (4 year degree) and for the students who have joined 4 year B. Tech programme and may opt for 5 year B. Tech –M. Tech programme at a suitable time, the Senate resolved that a five member committee will be formed under the Chairmanship of Dean Academic Affairs with Prof. Kalyan Bhar of Civil Engineering Department, Prof. Gautam Bandyopadhyay of Electrical Engineering Department, Prof. Biplab Sikdar of Computer Science and Technology Department and General Secretary Students' Senate. The committee will submit its report to the Senate as early as possible so that Senate can take a decision in the next meeting to resolve the issue. It was further decided that till such time Dean, Academic Affairs will issue the necessary certificate to the students regarding the course they are perusing on a case to case basis.

Since there was no other matter for discussion, the meeting ended with vote of thanks to the chair.
